libraries, and public safety facilities. As County services and properties increased over time, so did the need for security and communications systems at the properties.

In 2016, the County compiled all of the information on the different security and communications systems that had been installed over the years, as well as those properties that lacked such systems. They realized that a comprehensive, technologybased solution was needed. In collaboration with the people of Cabarrus County, the County initiated an effort to unify and modernize the security and communications systems throughout the County network of properties. The initiative was deemed a necessary step to provide effective public and employee safety, property security, and stewardship of the resources entrusted to the County government.

## Solution

The County requested proposals from interested security and IT companies and awarded the project to Brady. Todd Shanley, Deputy Director of IT for the County, oversaw the planning and installation, and worked closely with Brady throughout the project. From the very start Mr. Shanley found working with Brady to be a true partnership focused on designing and implementing systems that would best meet County expectations and facilityspecific needs. "This was a big project that included a lot of different needs at different properties," says Mr. Shanley, "and Brady met every one of those needs with a positive, problem-solving approach."

Brady designed an integrated software network that connected County properties and upon which property-specific systems

could be built. The project was then conducted in phases, beginning with the County detention center. Brady designed and installed a new video monitoring system using a digital internet protocol (IP), "a huge improvement over the old analog system," reports Mr. Shanley. The new IP system provides detention center staff with real-time monitoring, archiving, and retrieval capabilities. Brady also designed and installed updated access control and intercom systems at the detention center. All of these improved systems provide detention center staff with the ability to remotely monitor and control access. activity, and communication throughout the facility—crucial needs in any public safety facility.

Brady then designed and installed access control systems at 11 other county properties. Brady worked with Mr. Shanley to select the system components that best met each facility's specific needs while also saving the County money. "I really appreciate that Brady doesn't use a cookiecutter approach," explains Mr. Shanley. "They don't just use and push one product line, which means they can custom design each system to fit the need."

Brady next designed and installed video monitoring systems at properties such as office buildings, storage areas, parks, and others. The final phase was the design and installation of an interconnected intercom system that allows for real-time communication throughout the property network. Each of these systems is an important component of the County's comprehensive safety, security, and communications network.



## Results

With the completion of these customdesigned and interconnected systems, Cabarrus County is enjoying comprehensive, state-of-the-art security and communications throughout its network. The video monitoring systems enhance public and employee safety, as well as help to secure County property. The integrated intercom system enables real-time communication of routine and emergency information, which enhances safety and responsiveness within the County network.

Mr. Shanley credits much of the success of the overall project to Brady's expertise and collaborative work ethic. "Brady made this multi-phase project a seamless effort," he says, "and no matter the challenge, they found the best solutions for our needs."
